1. Haverfordwest

1.1 No waiting at any time

Stepney Terrace, Prendergast

East side – from a point 16 Metres south of the gable end wall of no. 1 Stepney Terrace, south for 12 metres

2 Johnston

2.1 Removal of Prohibition of stopping on School Keep clear Markings Mon – Fri 8am – 5pm

Cranham Park

West side – From a point 2 metres north of the school main access, north then west for 31.5 metres.

3. Manorbier

3.1 No waiting 9am - 7pm between 01 May and 15 September

U6338 Coast Road

South side – From a point 310 metres north west of the western end of the layby north west for a further 215 metres (extends current restriction)

The Pembrokeshire County Council ('the Council') in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46,49, 53, 101, 102, 124 and part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") as amended, the provisions of the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers of the Act, and after consulting the Chief Officer of Police in accordance with Part IV of Schedule 9 to the 1984 Act hereby make the following Order:-

- 1. This Order shall come into operation on the day of 2025 and may be cited as the Pembrokeshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2011 (Variation No. 31) Order 2025.
- 2. The Pembrokeshire County Council (Prohibition and Restriction of Waiting, Loading and Parking Places) Consolidation Order 2011 ("the Consolidation Order") including the schedules contained therein and subsequent variations are hereby varied or amended as follows:-

1) Amendment of Schedule 2

(a) In Schedule 2.1, insert:-

Haverfordwest

Stepney Terrace, Prendergast

East side – from a point 16 metres south of the gable end wall of no. 1 Stepney Terrace, south for 12 metres.

Milford Haven

Warwick Road

North side – from the centre of Brook Avenue eastwards for a length of 10 metres.

Narberth

Halkon Crescent

North, west and south side – From the boundary of numbers 22/23 Halkon Crescent around the turning head to a point directly opposite the boundary of no. 22/23 Halkon Crescent.

(b) Schedule 2.1 of the Order is amended as follows:-

Milford Haven

Warwick Road, for paragraph relating to both sides, substitute:

Both sides - From the junction with Great North road westwards for a length of 10 metres.

(c) In Schedule 2.13 of the Order is amended as follows:-

Manorbier

U6338 Beach Road for paragraph related to south side (b), substitute:

b) from the western end of the layby/parking bays for a distance of 525 metres to a point near the farm gate accesses beyond Atlantic View.


Statement of Reason




