

PEMBROKESHIRE COUNTY COUNCIL

(PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) (CONSOLIDATION) ORDER 2011 (VARIATION NO.31) ORDER 2025

The Pembrokeshire County Council ('the Council') in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 49, 53, 101, 102, 124 and part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") as amended, the provisions of the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers of the Act, and after consulting the Chief Officer of Police in accordance with Part IV of Schedule 9 to the 1984 Act hereby make the following Order:-

1. This Order shall come into operation on the 27th day of October 2025 and may be cited as the Pembrokeshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2011 (Variation No. 31) Order 2025.
2. The Pembrokeshire County Council (Prohibition and Restriction of Waiting, Loading and Parking Places) Consolidation Order 2011 ("the Consolidation Order") including the schedules contained therein and subsequent variations are hereby varied or amended as follows:-

1) Amendment of Schedule 2

(a) In Schedule 2.1, insert:-

Haverfordwest

Stepney Terrace, Prendergast

East side – from a point 16 metres south of the gable end wall of no. 1 Stepney Terrace, south for 12 metres.

Milford Haven

Warwick Road

North side – from the centre of Brook Avenue eastwards for a length of 10 metres.

Narberth

Halkon Crescent

North, west and south side – From the boundary of numbers 22/23 Halkon Crescent around the turning head to a point directly opposite the boundary of no. 22/23 Halkon Crescent.

(b) Schedule 2.1 of the Order is amended as follows:-

Milford Haven

Warwick Road, for paragraph relating to both sides, substitute:

Both sides - From the junction with Great North road westwards for a length of 10 metres.

(c) In Schedule 2.13 of the Order is amended as follows:-

Manorbier

U6338 Beach Road for paragraph related to south side (b), substitute:

b) from the western end of the layby/parking bays for a distance of 525 metres to a point near the farm gate accesses beyond Atlantic View.

2) Amendment of Schedule 4

(a) Schedule 4.4 of the order is amended as follows:-

Narberth

St James Street, north side - paragraph is deleted.

3) Amendment of Schedule 6

(a) In Schedule 6.1 insert:-

B4316 Pentlepoir to Saundersfoot road

North side

From a point 6 metres east of the Train Station car park entrance eastwards for 25 metres.

4) Amendment of Schedule 9

(a) Schedule 9.1 is amended as follows:-

Johnston

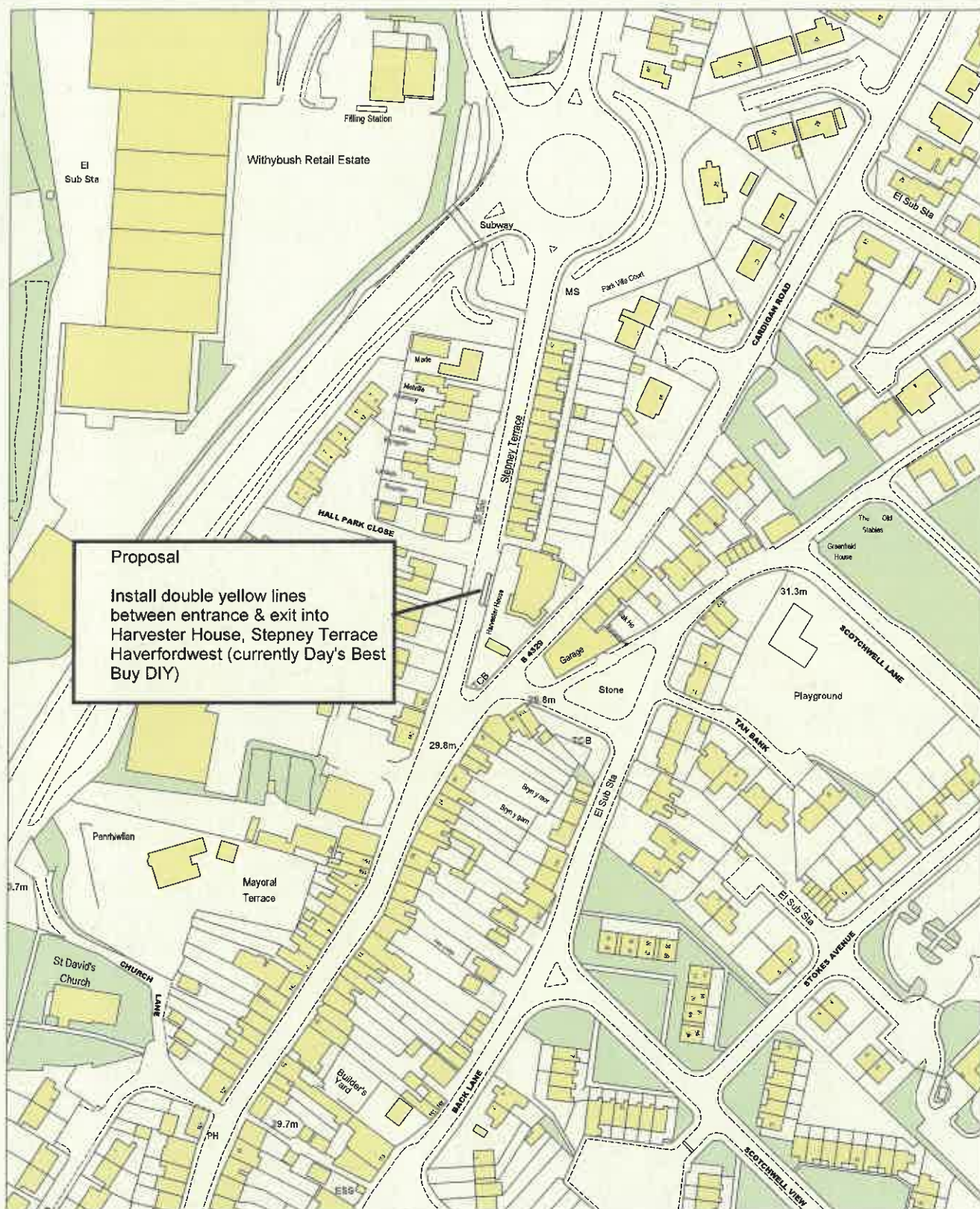
Cranham Park, west side – paragraph is deleted.

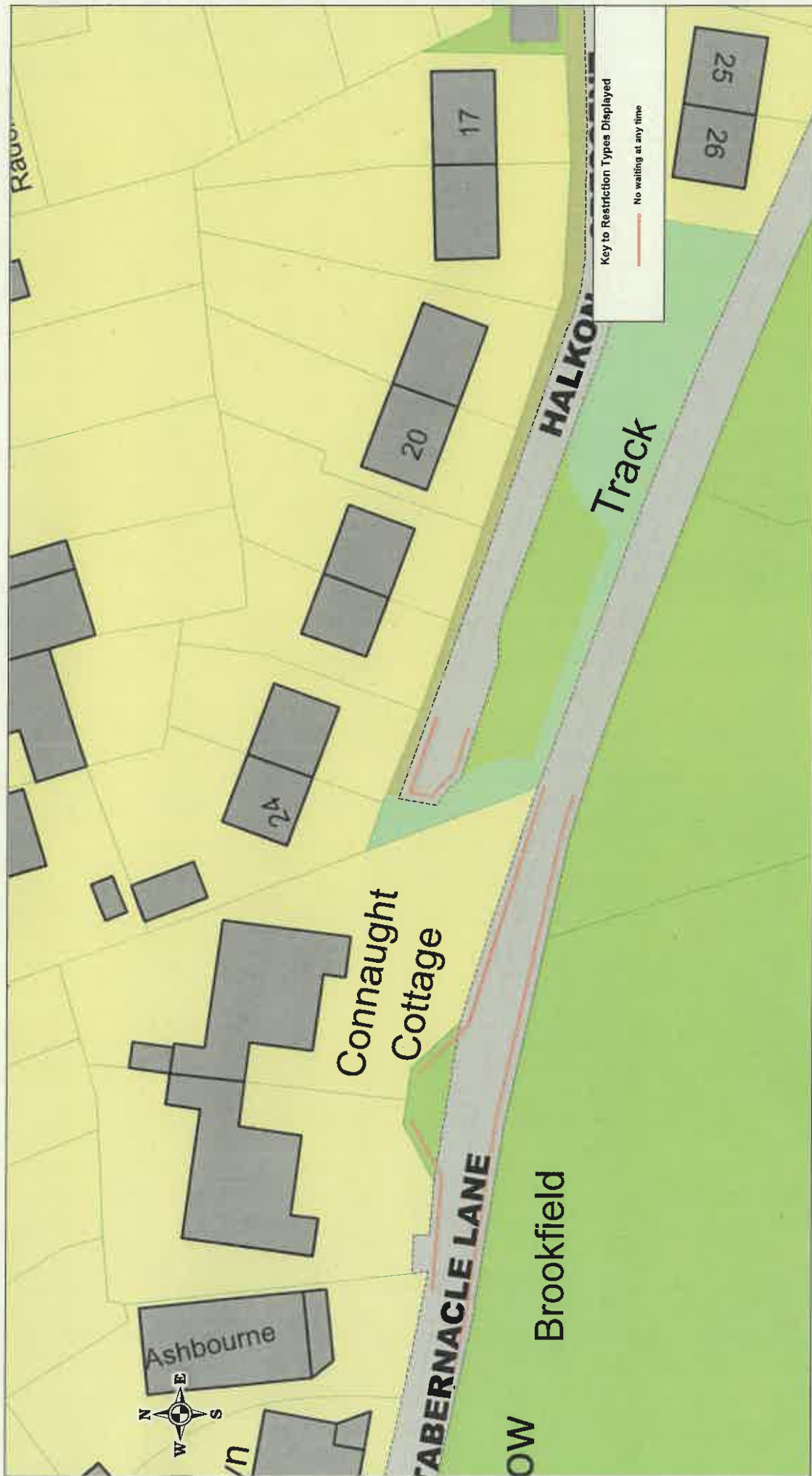
