a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

The sale of alcohol will not be the main products sold.
The main products will be tea, coffee, cakes and biscuits etc and the premises will be open early in the morning for the sale of those products only.

b) The prevention of crime and disorder

Incident register will be maintained.
CCTV system is installed inside and outside premises.
The system must incorporate a means of transferring images from the hard drive to a format that can be played back on any Windows compatible computer.
The system must be capable of recording and retaining 31 days of images before over-recording.
Recording equipment must record date and time information as part of the image file, and the date/time must be accurate.
There must be a competent person present on the premises capable of replaying and exporting recordings quickly and electronically to a responsible authority as defined by the Licensing Act 2003 as soon as possible upon a request.
The system must be registered with the Information Commissioner.

c) Public safety

A risk assessment will be maintained for fire, and trip hazards.
We do regular inspection of all our kit and equipment.
All sales of alcohol will be in aluminium sealed containers.
No glassware will be used.
Eye wash station maintained, first aid packs, fire extinguishers & fire blankets that all our team will be trained with.

d) The prevention of public nuisance

A priority is to minimise disturbance to neighbour's and the local area.
A POD selling alcohol, would be a great addition including some fantastic feedback from some local research we have done including the Transport for Wales management team and particularly liked the idea as it would increase positive customer feedback for the station facilities.
Only sealed containers of alcohol will be sold i.e. cans of G&T, locally sourced Welsh beers/ciders from cans, and mini bottles of Prosecco etc,
Customers also have the option to take their purchases onto the train for a comfortable and enjoyable onwards train journey.
Sealed bins will be provided in compliance with current regulations.

e) The protection of children from harm

No sale of alcohol to persons under the age of eighteen years.
We will operate a challenge 25 policy.
Any person attempting to purchase alcohol who is suspected to be under the age of twenty-five years will be asked for identification in the form of a driving licence, passport or PASS card and if neither document is produced no sale will be made. A register will be maintained of all attempted sales of alcohol which are refused.
Any person consuming alcohol on premises who is suspected to be under the age of eighteen years will be asked for identification in the form of a driving licence or passport and if neither document is produced the alcohol will be confiscated.
List of persons will be maintained that are authorised to sell alcohol.

Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.

- and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
 - Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
 - Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

Any personal licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have the right to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensing activity. They do this in one of two ways:

- 1) by providing with this application copies or scanned copies of the documents which an applicant may provide to demonstrate their entitlement to work in the UK (which do not need to be certified) that are published on GOV.UK and in [guidance issued under section 182 of the Licensing Act 2003](#).
- 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

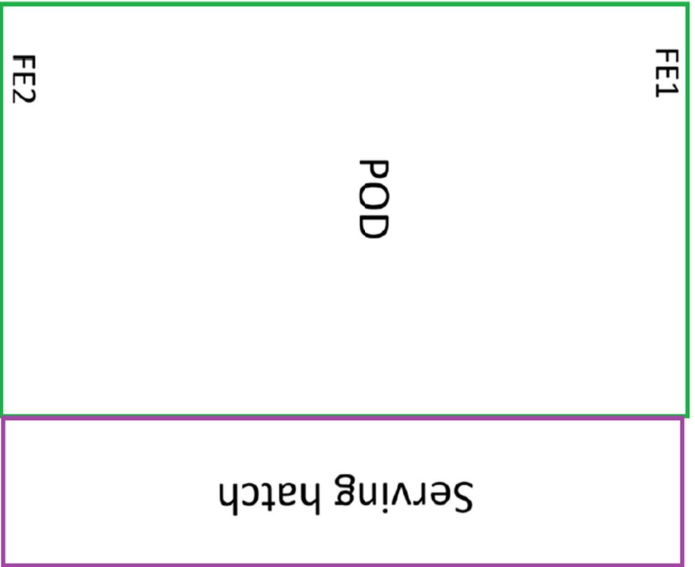
An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be checked online. The Home Office online right to work checking service sets out what information and/or documentation applicants will need in order to access the service. Applicants who are unable to obtain a share code from the service should submit copy documents as set out above.

Legend

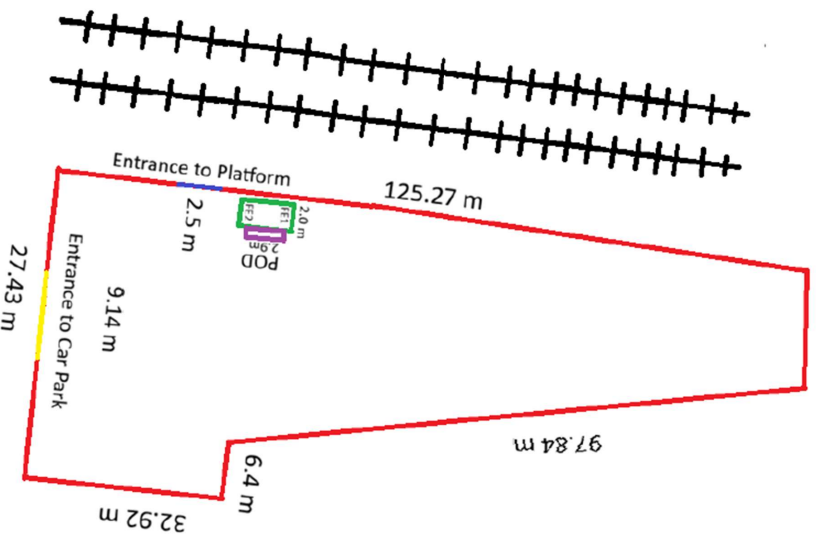
- FE1 - Fire extinguisher
