

**CYNGOR SIR PENFRO, Neuadd y Sir, Hwlfordd, Sir Benfro, SA61 1TP (y cyfeirir ato o hyn ymlaen fel “Cyngor Sir Penfro”).**

Rhoddir hysbysiad yn unol ag adran 43 o Ddeddf Safonau a Threfniadaeth Ysgolion (Cymru) 2013 a'r Cod Trefniadaeth Ysgolion bod Cyngor Sir Penfro, ar ôl ymgynghori â'r personau hynny yn ôl yr angen, yn bwriadu cau Ysgol Clydau, Tegryn, Llanfyrnach, SA35 0BE. Ar hyn o bryd, cynhelir yr ysgol gan Gyngor Sir Penfro.

Fel cynigydd, cynhaliodd Cyngor Sir Penfro gyfnod o ymgynghori cyn penderfynu cyhoeddi'r cynnig hwn. Cafodd Adroddiad Ymgynghori sy'n cynnwys crynodeb o'r materion a godwyd gan ymgynghoreion, ymatebion y cynigydd a barn Estyn ei ystyried gan y Cyngor Sir ac mae ar gael ar wefan y Cyngor ([www.sir-benfro.gov.uk/dweud-eich-dweud/ymgyngoriadau](http://www.sir-benfro.gov.uk/dweud-eich-dweud/ymgyngoriadau)).

Cynigir ailddynodi dalgylch Ysgol Clydau yn ddalgylch Ysgol Bro Preseli, Crymych, Sir Benfro, SA41 3QH o 1 Medi 2026 ymlaen.

Mae Ysgol Bro Preseli yn ysgol iaith categori 3 – ysgol cyfrwng Cymraeg dynodedig 3-19 oed.

Nid oes angen cymryd unrhyw fesurau eraill i gynyddu nifer y lleoedd ysgol.

Bydd cludiant rhwng y cartref a'r ysgol yn cael ei ddarparu yn unol â Pholisi Cludiant rhwng y Cartref a'r Ysgol yr awdurdod ar ddyddiad gweithredu'r cynnig.

Gwelir mai gweithredu'r cynnig i gau Ysgol Clydau yw'r ymateb mwyaf priodol i'r rhesymau a nodwyd wrth lunio'r cynnig oherwydd y ffactorau canlynol

- Nifer sylweddol o leoedd gwag
- Sicrhau cynaliadwyedd darpariaeth addysg yn ardal Preseli yn y dyfodol
- Cyflwr yr adeiladau presennol
- Gwerth am arian

**PEMBROKESHIRE COUNTY COUNCIL of County Hall, Haverfordwest, Pembrokeshire, SA61 1TP (hereinafter referred to as “Pembrokeshire County Council”).**

Notice is given in accordance with sections 43 of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code that Pembrokeshire County Council, having consulted such persons as required, proposes to discontinue Ysgol Clydau, Tegryn, Llanfyrnach, SA35 0BE. The school is currently maintained by Pembrokeshire County Council.

As proposer, Pembrokeshire County Council undertook a period of consultation before deciding to publish this proposal. A Consultation Report containing a summary of the issues raised by consultees, the proposer's responses and the views of Estyn was considered by the County Council and is available on Council's website ([www.pembrokeshire.gov.uk/haveyoursay](http://www.pembrokeshire.gov.uk/haveyoursay)).

It is proposed to implement the proposals on 31<sup>st</sup> August 2026.

From 1<sup>st</sup> September 2026 it is proposed that the catchment area of Ysgol Clydau be redesignated a catchment area of Ysgol Bro Preseli, Crymych, Pembrokeshire, SA41 3QH.

Ysgol Bro Preseli is a language category 3 – designated Welsh medium 3-19 all through school.

It is not necessary to take any other measures to increase the number of school places.

Home to School Transport will be provided in accordance with the Authority's Home to School Transport Policy as at the date of the implementation of the proposal.

The implementation of the proposal to discontinue Ysgol Clydau is seen as the most appropriate response to address the reasons identified in formulating the proposal due to the following factors

- Significant surplus places
- Ensures future sustainability of education provision in Preseli area
- Condition of existing buildings
- Value for money

### Explanatory Note:

**(This explanatory note does not form part of the Notice but is offered by way of explanation)**

1. Pembrokeshire County Council proposes to cease to maintain Ysgol Clydau with effect from 31st August 2026 and to make provision for those pupils currently attending and living within the current catchment area of that school to attend Ysgol Bro Preseli.
2. As of 1st September 2026, the catchment area for Ysgol Bro Preseli will be extended to incorporate the current catchment area of Ysgol Clydau.
3. Ysgol Bro Preseli is a Welsh medium 3-19 school. The capacity of the primary element is 210 and the Admission Number is 30 for 2026/27.
4. Transport arrangements will be made for pupils who qualify under the Councils Home to School Transport Policy.
