a) General – all four licensing objectives (b, c, d and e) (please read guidance note 11)

All of our existing operating procedures and management controls will remain in place and will continue to apply following the proposed variation. These include staff training, age-verification procedures, monitoring of customer behaviour, management oversight of the premises, and steps to minimise disturbance to neighbouring properties. The premises will continue to be operated in a responsible manner with appropriate, necessary and proportionate measures in place to promote all four licensing objectives

b) The prevention of crime and disorder

We will continue to operate a refusals policy and age-verification procedure for alcohol sales, with staff trained to refuse service where appropriate. An incident log will be maintained and made available to authorised officers on request. Management and staff will monitor customer behaviour and will refuse service to any person who appears intoxicated or is acting in a disorderly manner.

c) Public safety

The premises will continue to be properly managed to ensure the safety of customers, staff and visitors at all times. Fire safety equipment, emergency exits and lighting will be maintained in good working order, and staff will be familiar with emergency procedures. Customer numbers will be monitored so that the premises do not become overcrowded, and the layout of the premises and any outside areas will be managed to maintain safe access. Glassware and external drinking areas will be controlled where necessary to reduce risk.

d) The prevention of public nuisance

We recognise the need to operate with due regard to nearby residents and neighbouring businesses. Staff will monitor noise levels from guests, music and any external areas, and reasonable steps will be taken to keep doors and windows closed when appropriate and to ensure customers leave the premises quietly. Any outside area will be supervised and managed responsibly, and litter arising from customers will be cleared regularly so that the immediate vicinity of the premises is kept tidy.

The premises will continue to operate an age-verification policy, Challenge 25, requiring acceptable photographic identification for anyone who appears under the relevant age. Staff will receive training on underage sales prevention and refusals, and children on the premises will remain under the supervision of responsible adults where appropriate. No alcohol will be sold or supplied to persons under 18, and staff will remain vigilant to ensure that children are not exposed to unsuitable situations or harm while on the premises. Pembrokeshire's published model conditions include age-verification and restrictions relating to children

Notes for Guidance

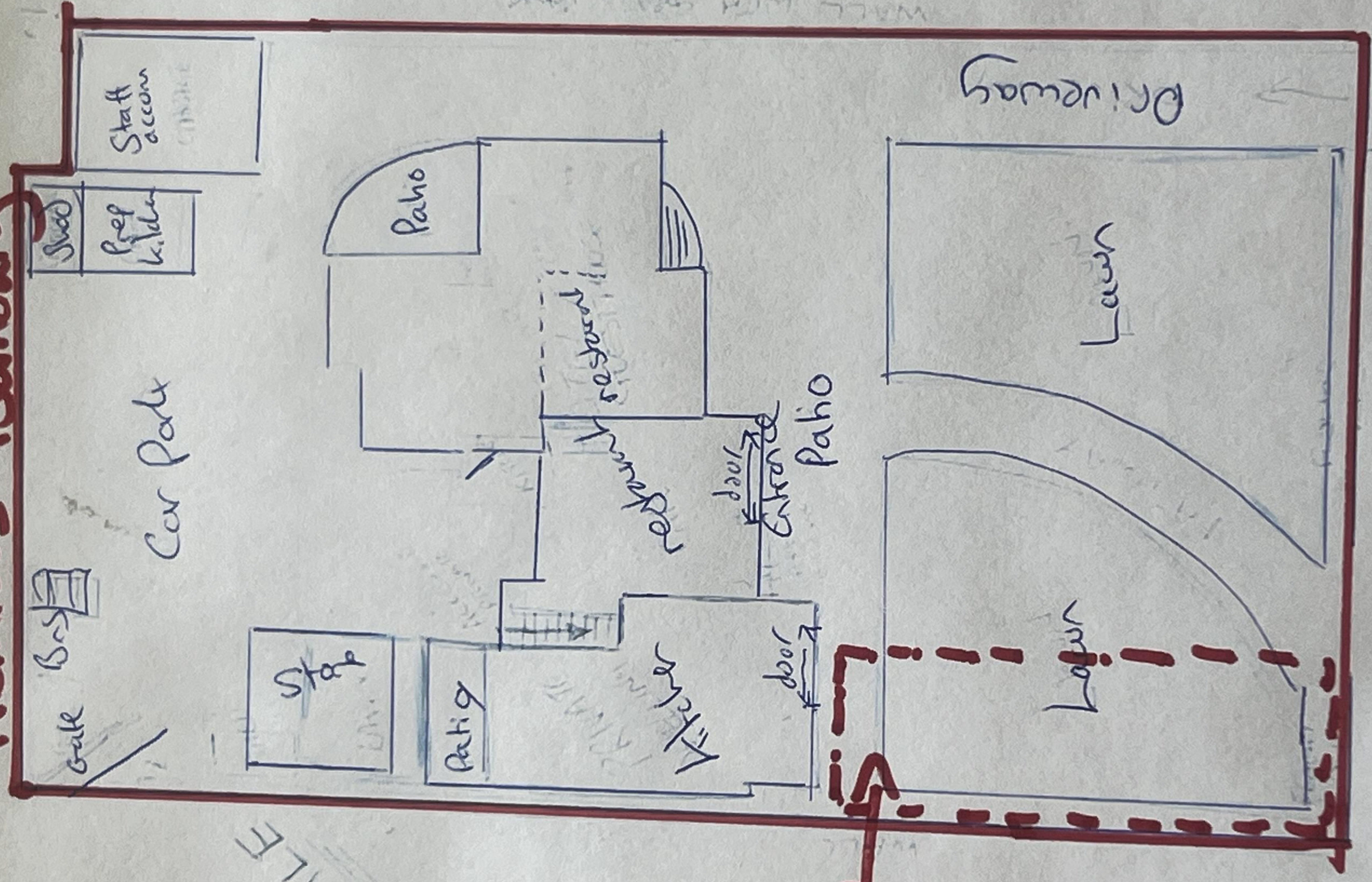
This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary substantially the premises to which it relates. If you wish to make that type of change to the premises licence, you should make a new premises licence application under section 17 of the Licensing Act 2003.

1. You do not have to pay a fee if the only purpose of the variation for which you are applying is to avoid becoming liable for the late night levy
2. Describe the premises. For example, the type of premises, its general situation and layout and any other information which could be relevant to the licensing objectives. Where your application includes off-supplies of alcohol and you intend to provide a place of consumption of these off-supplies of alcohol, you must include a description of where the place will be and its proximity to the premises.
3. In terms of specific regulated entertainments please note that:
 - Plays: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500.
 - Films: no licence is required for ‘not-for-profit’ film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
 - Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.

- a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
 - Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
 - Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
 - Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
