Nomination papers should be delivered by hand to the **RETURNING OFFICER, COUNTY HALL, HAVERFORDWEST, PEMBROKESHIRE, SA61 1TP** between the hours of **10.00am and 4.00pm** on any working day from the date of this Notice, but no later than **4.00pm on 12<sup>th</sup> JUNE 2026** (appointments must be made to deliver nomination papers in person. Appointments can be made by email to [electoralservices@pembrokeshire.gov.uk](mailto:electoralservices@pembrokeshire.gov.uk) ). Alternatively nomination papers may be submitted electronically by scanning the completed nomination papers and emailing to [Returningofficer@pembrokeshire.gov.uk](mailto:Returningofficer@pembrokeshire.gov.uk) no later than **4.00pm on 12<sup>th</sup> JUNE 2026**.
4. If the Election is contested, the poll will take place on **THURSDAY 9<sup>th</sup> JULY 2026**.
5. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on **23<sup>rd</sup> JUNE 2026**. Applications can be made online: <https://www.gov.uk/register-to-vote>.
6. Alterations to existing arrangements for postal voting by electors or their proxies who already have an indefinite or fixed period postal vote, or new postal vote applications, must reach the **ELECTORAL REGISTRATION OFFICER, ELECTORAL SERVICES, COUNTY HALL, HAVERFORDWEST, PEMBROKESHIRE, SA61 1TP**, by no later than **5.00pm on 24<sup>th</sup> JUNE 2026**.
7. Applications to vote by proxy must reach the **ELECTORAL REGISTRATION OFFICER, ELECTORAL SERVICES, COUNTY HALL, HAVERFORDWEST, PEMBROKESHIRE, SA61 1TP** by no later than **5.00pm on 1<sup>st</sup> JULY 2026**.
8. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the **ELECTORAL REGISTRATION OFFICER, ELECTORAL SERVICES, COUNTY HALL, HAVERFORDWEST, PEMBROKESHIRE, SA61 1TP** by **5.00 pm on 9<sup>th</sup> JULY 2026**. The physical incapacity must have occurred **after 5.00pm on 1<sup>st</sup> JULY 2026**. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after **5.00pm on 1<sup>st</sup> JULY 2026**.
