

**CYNGOR SIR PENFRO, Neuadd y Sir, Hwlfordd, Sir Benfro, SA61 1TP (y cyfeirir ato o hyn ymlaen fel “Cyngor Sir Penfro”).**

Rhybuddir yn unol ag adrannau 41 a 43 Deddf Safonau a Threfniadaeth Ysgolion Cymru (2013) a'r Cod Trefniadaeth Ysgolion (Gorffennaf 2013) bod Cyngor Sir Penfro, ar ôl ymgynghori â'r personau angenrheidiol, yn bwriadu gweithredu:

1. O 31 Rhagfyr 2018 ymlaen, i ddirwyn i ben yr ysgolion canlynol sydd ar hyn o bryd yn cael eu cynnal gan Gyngor Sir Penfro:
  - Ysgol Feithrin a Babanod Mount Airey, Augustine Way, Hwlfordd, SA61 1PA.
  - Ysgol Wirfoddol Rheoledig yr Eglwys yng Nghymru Hwlfordd, Barn Street, Hwlfordd, SA61 1TD. (Mae gan yr ysgol hon gymeriad crefyddol a chaiff y disgyblion eu haddysgu yn ôl athrawiaethau'r Eglwys Anglicanaidd. Esgobaeth Dewi Sant yw'r corff crefyddol priodol).
2. O'r 1 Ionawr 2019, i sefydlu ysgol gymunedol newydd 3-11 ar gyfer bechgyn a merched ar safleoedd yr ysgolion presennol, i'w chynnal gan Gyngor Sir Penfro. Categori iaith yr ysgol fydd Cyfrwng Saesneg (CS) ac ni fydd ganddi gymeriad grefyddol.

Fel y cynigydd, ymgwymerodd Cyngor Sir Penfro â chyfnod o ymgynghori cyn penderfynu cyhoeddi'r cynnig hwn. Mae Adroddiad Ymgynghori sy'n cynnwys crynodeb o'r materion a godwyd gan y rhai yr ymgynghorwyd â hwy, ymatebion y cynigydd a barn Estyn wedi ei ystyried gan y Cyngor Sir ac mae ar gael ar wefan y Cyngor ([www.pembrokeshire.gov.uk](http://www.pembrokeshire.gov.uk)).

Yr Awdurdod Derbyn fydd Cyngor Sir Penfro. Ni fydd trefniadau derbyn ar gyfer yr ysgol newydd yn gwneud unrhyw ddarpariaeth ar gyfer bandio disgyblion. Y Rhif Derbyn ar gyfer pob grŵp blwyddyn perthnasol yr ysgol newydd yn ystod y flwyddyn ysgol gyntaf pan fydd y cynigion yn cael eu gweithredu fydd 46. Bydd lle i 326 o ddisgyblion yn yr ysgol newydd. Mae'n fwiad fod pob disgybl fydd yn mynychu'r ysgolion presennol ar y dyddiad gweithredu yn cael lle yn yr ysgol arfaethedig.

Bydd Cludiant o'r Cartref i'r Ysgol yn cael ei ddarparu yn unol â Pholisi Cludiant o'r Cartref i'r Ysgol yr awdurdod o ddyddiad gweithredu'r cynnig.

**PEMBROKESHIRE COUNTY COUNCIL of County Hall, Haverfordwest, Pembrokeshire, SA61 1TP (hereinafter referred to as “Pembrokeshire County Council”).**

Notice is given in accordance with sections 41 and 43 of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code (July 2013) that Pembrokeshire County Council, having consulted such persons as required, proposes to implement :

1. As from 31<sup>st</sup> December 2018, discontinue the following schools currently maintained by Pembrokeshire County Council:
  - Mount Airey Nursery and Infants School, Augustine Way, Haverfordwest, SA61 1PA.
  - Haverfordwest Church in Wales Voluntary School, Barn Street, Haverfordwest, SA61 1TD. (This school has a religious character and pupils are taught according to the doctrines of the Anglican Church. The Diocese of St David's is the appropriate religious body).
2. As from 1<sup>st</sup> January 2019, establish a new all through 3-11 community school for boys and girls on the sites of the existing schools, to be maintained by Pembrokeshire County Council. The language category of the school will be English Medium (EM) and the school will not have a religious character.

As proposer, Pembrokeshire County Council undertook a period of consultation before deciding to publish this proposal. A Consultation Report containing a summary of the issues raised by consultees, the proposer's responses and the views of Estyn was considered by the County Council and is available on the Council's website ([www.pembrokeshire.gov.uk](http://www.pembrokeshire.gov.uk)).

The Admission Authority will be Pembrokeshire County Council and admission arrangements for the new school will not make provision for pupil banding. The admission number for each relevant age group for the new school in the first school year in which the proposals will be implemented will be 46. The new school's pupil capacity will be 326. It is intended that all pupils attending the current schools as at the implementation date will have places in the proposed school.


Home to School Transport will be provided in accordance with the Authority's Home to School Transport Policy as at the date of the implementation of the proposal.

#### **Nodyn Esboniadol:**

1. Mae Cyngor Sir Penfro yn bwriadu rhoi'r gorau i gynnal Ysgol Feithrin a Babanod Mount Airey ac Ysgol Wirfoddol Rheoledig Hwlfordd, o 31 Rhagfyr 2018 ac yn bwriadu, o 1 Ionawr 2019, sefydlu ysgol gymunedol newydd 3-11 ar safleoedd y ddwy ysgol presennol.
2. Y Cyngor Sir fydd yr Awdurdod Derbyn; fel y cyfryw bydd disgyblion newydd yn mynychu (yn amodol ar ddewis rhieni) yn unol â Pholisi Derbyn y Cyngor.
3. Er mwyn lliniaru colli ysgol ffydd, cynigir ymestyn dalgyloch Ysgol Wirfoddol a Gynorthwyir yr Eglwys yng Nghymru Sant Mark. Bydd hyn yn sicrhau bod rhieni, a fyddai fel arall wedi mynegi ffafiaeth am Ysgol Wirfoddol a Reolir Hwlfordd oherwydd cymeriad crefyddol dynodedig yr ysgol, yn gallu gwneud cais am leoedd yn Ysgol Wirfoddol a Gynorthwyir Sant Marc.
4. Bydd Corff Rheoli Dros Dro ar gyfer yr ysgol newydd yn cael ei sefydlu a bydd yn gyfrifol am:
  - Benodi Pennaeth Ysgol
  - Enwi'r ysgol newydd
  - Sefydlu'r weledigaeth a'r ethos
  - Gwneud trefniadau cyfundrefnol yn cynnwys y cwricwlwm a lleoedd dysgu
  - Cyfrifoldeb am agoriad yr ysgol newydd hyd yr amser y bydd corff llywodraethu newydd yn ei le.

Within a period of 28 days after the date of publication of these proposals, that is to say by 11<sup>th</sup> June 2018, any person may object to the proposals.

#### **Explanatory Note:**

**(This explanatory note does not form part of the Notice but is offered by way of explanation)**

1. Pembrokeshire County Council proposes to cease to maintain Mount Airey Nursery and Infants School and Haverfordwest VC School with effect from 31<sup>st</sup> December 2018 and propose, as from 1<sup>st</sup> January 2019, to establish a new 3-11 community school in Haverfordwest, using the sites of the existing schools.
2. The County Council will be the Admissions Authority; as such new pupil entrants will attend (subject to parental preference) in accordance with the Council's Admissions Policy.
3. In order to mitigate the loss of a faith school, it is proposed to extend the catchment area of St Mark's Church in Wales Voluntary Aided School. This will ensure that parents, who would have otherwise expressed a preference for Haverfordwest VC School on the grounds of the school having a designated religious character, will be able to apply for places at St Mark's VA School.
4. A Temporary Governing Body for the new school will be established and will be responsible for:
  - Appointment of Headteacher
  - Naming of the new school
  - Establishing the vision and ethos
  - Making organisational arrangements including curriculum and accommodation
  - Responsibility for the opening of the new school until such time as the new governing body is in place.
