

**THE COUNTY OF PEMBROKE (C3004 CILGERRAN)
(RESTRICTED ROADS AND 30MPH SPEED LIMIT) (AMENDMENT No.3) ORDER 2021**

NOTICE is hereby given that Pembrokeshire County Council propose to make an Order under Sections 82, 83 and 84, and part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), the effect of which will be to amend 'The County of Pembroke (Various Roads) (Restricted Roads and 30mph Speed Limit) Order 2017' as though in Schedule 2 the following applies:

Schedule 2 – 30mph Speed Limit

1. In Schedule 2 insert:

1.13.0	Cigerran		Length of Road
	Cilgerran to Pen-y-bryn road (3004)		ii) From a point 91 metres west of the junction with Castle square to a point 310 metres east of the junction with Melin-Y-Coed.

Note – the proposal looks to extend the current 30mph limit at Cilgerran, East to include the extent of the built development.
